

## Club Ends Year With Christmas Party




2025 ended with a bang of a party as IEMC members enjoyed the annual Christmas get-together and gift exchange at Darcy's restaurant.



December 2, 2025

**Meeting called to order at 7pm** by Tom Seep. The Pledge of Allegiance was recited by the membership.

### President's Comments:

- Two main topics for the night's meeting... 1) Elections, and 2) Charitable giving.
- **Barry/Elections** Tom turned the floor over to Barry Barton to introduce the nominees and to go over the election process. The following positions/nominees were presented for voting: President – Carl Sontowski; Vice President – Gary Gunning; Treasurer – Bruce Butler; Secretary – Kim Frank; Board Members (voting for 2) – Diane Harwood, Mike Bishop.
- No other names were submitted for nomination by the membership.

### **50/50:** Marsha Sundberg: Marsha awarded \$51 to herself.


